#### DATA REQUIRED BY THE PRIVACY ACT OF 1974:

1. Authority: Title 10 USC 3012 (Section 2101 and 2111)
2. Principle Purpose: To obtain information to determine eligibility for participation in the Army ROTC Program; to provide information necessary for processing Basic Camp and advanced ROTC applications.
3.
